He was especially generous to youth groups with the goal of nurturing their interest in the cattle business.

VALUE OF SCHOLARSHIP:

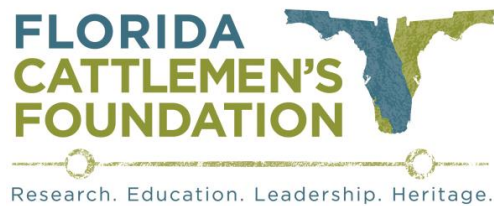
Two awards in the amount of \$1,000 will be awarded. This will be awarded at the annual FCA Annual Convention. The recipient (s) will be notified no later than May 15 of each year to allow for the opportunity to attend the awards ceremony at the convention, which is usually held during the month of June.

Financial award maybe used for Tuition & Fees only.

Award will be distributed in one single Semester and will be payable to the institution at which the student is enrolled in.

ELIGIBILITY:

- 1. The applicant must be a member of the FCA or have a family member of the Florida Cattlemen's Association in good standing at least six months prior to submitting application for scholarship (October 1 of year prior to applying in April).**
- 2. Scholarship applicant must be enrolled as a full-time student in a Florida post-secondary state or private institution, and must have completed courses to satisfy at least the sophomore requirements, so that the student will be entering at least the junior year or post graduate courses during the year the scholarship is awarded.**
- 3. Applicant must have an Agricultural related major of study**
- 4. Applicant must show a minimum of a 2.0 GPA**



STEPS FOR APPLYING

- 1. Type or print application form.**
- 2. Submit a letter of recommendation.**
- 3. Complete a typed 300-600 word essay on the given topic.**
Essay topic: How has agriculture affected your life and what aspect will your college plans further your agricultural goals?
- 4. Submit the most up-to-date transcript available at the time of the application deadline. Include a copy of college transcripts to date.**
- 5. DEADLINE - Application and all supportive materials must be compiled and mailed under single cover to the office of the Florida Cattlemen's Foundation; PO Box 421929, Kissimmee, Florida 34742-1929. These materials must be POST MARKED NO LATER THAN April 1st of each year.**
